

END-USER LICENSE AGREEMENT (HAPTISYNC STREAM DECK PLUGIN)

This End-User License Agreement (“Agreement”) is entered into solely between D-BOX Technologies Inc. (“D-BOX”) and the individual or entity that downloads, installs, accesses, or uses the Software (“You”). This Agreement does not involve Corsair Memory, Inc. or any of its affiliates (“Corsair”). The software code, application programming interfaces (APIs), libraries, documentation, haptic code, and any related materials made available by D-BOX are collectively referred to in this Agreement as the “Software”.

BY DOWNLOADING, INSTALLING, ACCESSING, OR USING THE SOFTWARE, YOU ACCEPT THE TERMS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO THE TERMS OF THIS AGREEMENT, DO NOT DOWNLOAD, INSTALL, ACCESS, OR USE THE SOFTWARE. YOU FURTHER ACKNOWLEDGE AND AGREE THAT (I) THIS AGREEMENT IS CONCLUDED SOLELY BETWEEN YOU AND D-BOX, AND NOT WITH CORSAIR; AND (II) D-BOX, AND NOT CORSAIR, IS SOLELY RESPONSIBLE FOR THE SOFTWARE.

1. LICENSE GRANT: Subject to the terms of this Agreement, D-BOX grants You a non-exclusive, revocable, non-transferable, worldwide license to use the Software solely in connection with compatible Corsair products lawfully owned or controlled by You, and only for its intended purpose.

2. RESTRICTIONS: You shall not, directly or indirectly: (i) modify, disassemble, decompile, or reverse engineer any part of the Software; (ii) modify, adapt, alter, translate, incorporate into or with other software, or create derivative works of any part of the Software, except as expressly permitted under this Agreement; (iii) use the Software to develop, enable, or assist in the creation of any other software or service; (iv) remove, modify, obscure, or tamper with any proprietary notices, labels, or legends included in or displayed by the Software; (v) distribute, sublicense, sell, rent, lease, lend, transfer, or otherwise make available the Software to any third party, except through an authorized marketplace or distribution channel expressly approved by D-BOX; (vi) publish or make the Software available for copying or download outside of such authorized distribution channels; (vii) use the Software to create, develop, or use any program, software, or service that: (1) interferes with, diminishes, or takes away the functionality of D-BOX products or other D-BOX software; (2) exposes, discloses, or uses proprietary interfaces, header file information, or APIs except as expressly permitted; (3) contains viruses, Trojan horses, worms, logic bombs, cancel bots, or other malicious or harmful code; (4) when used as intended, violates any applicable law, statute, ordinance, or regulation, including without limitation laws governing export control, unfair competition, data protection, consumer protection, discrimination, or false advertising; or (5) interferes with the operability, performance, or security of D-BOX software, Corsair products, or any third-party program or service; or (viii) modify, distribute, or convey the Software in any manner that would subject it to an open-source or “copyleft” license or similar license that requires, as a condition of use, modification, or distribution, that: (1) the Software or any portion thereof be disclosed or distributed in source-code form; (2) others be permitted to modify or create derivative works of the Software; and/or (3) the Software or derivative works be redistributable at no charge.

You agree to use the Software only in conjunction with hardware supplied or expressly approved by D-BOX, including compatible Corsair products. You remain solely responsible and liable for any use or misuse of the Software by Your employees, contractors, consultants, or agents.

D-BOX may collect and process personal information in connection with the Software in accordance with its Privacy Policy, available at <https://www.d-box.com/en/privacy-policy/>. The Privacy Policy is informational and does not amend or form part of this Agreement.

3. EXPORT COMPLIANCE: You agree to comply with all applicable export control and sanctions laws and regulations governing the use, export, re-export, or transfer of the Software.

4. INTELLECTUAL PROPERTY: The Software, including without limitation all source code, object code, APIs, libraries, documentation, audiovisual elements, and associated materials, is owned by D-BOX and is protected by intellectual property laws. Except for the limited license expressly granted under this Agreement, no right, title, or interest in or to the Software or any intellectual property rights therein is transferred to You. Any feedback or technical information You provide to D-BOX may be used by D-BOX without restriction for product improvement, support, and development purposes.

5. MAINTENANCE AND SUPPORT: D-BOX is solely responsible for any maintenance or support provided for the Software. Corsair has no obligation whatsoever to provide maintenance, support, updates, or assistance of any kind with respect to the Software.

6. PRODUCT CLAIMS: You acknowledge that D-BOX, and not Corsair, is solely responsible for addressing any claims relating to the Software or its use, including: (i) product liability claims; (ii) consumer protection claims, and (iii) claims that the Software fails to comply with applicable laws or regulations.

7. DISCLAIMER: THE SOFTWARE IS PROVIDED "AS IS" AND "AS AVAILABLE", WITHOUT WARRANTIES OF ANY KIND. D-BOX DISCLAIMS ALL EXPRESS AND IMPLIED WARRANTIES, INCLUDING WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT. Some jurisdictions do not allow the exclusion or limitation of certain warranties. To the extent prohibited by law, these exclusions and limitations shall not apply.

8. LIMITATION OF LIABILITY: TO THE MAXIMUM EXTENT PERMITTED BY APPLICABLE LAW, D-BOX SHALL NOT BE LIABLE FOR ANY INDIRECT, INCIDENTAL, SPECIAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES ARISING OUT OF OR RELATED TO THE SOFTWARE OR ITS USE. Nothing in this Agreement limits liability to the extent such limitation is prohibited by applicable law.

9. INDEMNIFICATION: You agree to defend, indemnify, and hold harmless D-BOX and its affiliates from any claims, losses, liabilities, damages, and expenses (including reasonable attorneys' fees) arising out of or relating to: (i) Your use of the Software; (ii) any application You develop using the Software; or (iii) Your breach of this Agreement or applicable law.

10. TERMINATION: This Agreement remains in effect until terminated. You may terminate it at any time by ceasing use of the Software, except to the extent continued possession or use is permitted under applicable law or the terms of an authorized marketplace from which the Software was obtained. D-BOX may terminate this Agreement immediately if You fail to comply with its terms. Upon termination, all rights granted to You cease immediately.
