

**“WIN D-BOX/Digital Motorsports Haptic Simulator”  
SWEEPSTAKE  
OFFICIAL RULES**

1. The “WIN D-BOX/Digital Motorsport Haptic Simulator” Sweepstake (hereafter “**Sweepstake**”) is organized by D-BOX Technologies Inc. having its registered office at 2172 de la Province Longueuil J4G 1R7 Quebec Canada (“**D-BOX**”).

The Sweepstake starts on November 12<sup>th</sup>, 2022, at 12:00 AM (EDT) and closes on December 21<sup>st</sup>, 2022 at 11:59 PM (EDT). Any reference to time in this document indicates Eastern Daylight-saving Time (“**EDT**”).

**ELIGIBILITY**

2. The Sweepstake is only open to all residents of USA (void where prohibited including and not limited to Florida), Canada (excluding Quebec), Germany, Austria, Spain, Portugal, Nederland, Bulgaria, Denmark, Sweden, Norway, Ireland, UK (void where prohibited for the listed European countries), Mexico (void where prohibited), who are of the age of majority at the start date of this Sweepstake. Individual who wishes to participate this Sweepstake is responsible to verify the local law for participating.
3. Employees, agents and/or representatives of D-BOX and Digital Motorsport, its distributors or affiliated companies, advertising agencies or any contributor, if applicable, are prohibited from participating to the Sweepstake, as well as anyone with whom an employee, agent and/or representative is domiciled or any member of his or her immediate family. For these official rules, “immediate family” refers to the father, mother, brothers, sisters, children, husband, wife or partner of such an employee, agent and/or representative.

**HOW TO ENTER**

4. **Registration**

4.1 To participate to this Sweepstake, a participant (“**you**” or the “**Participant**”) must complete and comply with the following registration steps:

- a) Sign up to the “[www.d-box.com/enascar/contest](https://www.d-box.com/enascar/contest)” and complete the electronic entry form (“**Entry Form**”) by filling all required fields, which include providing your answer to a mathematical skill question if you are a Canadian resident (“**Mathematical Question**”) and a valid email address.
- b) Each Participant can only participate once by using one valid e-mail address to enter Sweepstake via the Entry Form.
- c) The same e-mail address cannot be used by more than once. Submitting multiple Entry Form for the same Participant will void the registration to the Sweepstake.
- d) Read and agree with these Sweepstake Official Rules as well as the D-BOX privacy policy (<https://www.d-box.com/en/privacy-policy/>) (“**Privacy Policy**”) by clicking on “Agree” box and “Submit” the Entry Form.

4.2 By participating to this Sweepstake, Participant agrees to be governed by these Sweepstake Official Rules and the Privacy Policy. All information provided by Participant in the Entry Form (such as first name, surname, e-mail address, postal address) is required to ensure participation in the Sweepstake and will be strictly used for the Sweepstake drawing purposes as well as notifying the Winner (as defined below) of the Prize (as defined below). The provided information is stored and governed according to these Rules and the Privacy Policy. The information of the non-winning Participants will be deleted or anonymized immediately after the end of the Sweepstake. D-BOX will not pass on Participants’ information to third parties. D-BOX has appointed a company data protection officer. 4.4 Purchase will not increase the chances of winning of the Participant.

4.5 D-BOX reserves the right to cancel or to exclude any participations if a Participant is in violation of the Rules of this Sweepstake.

**DRAW**

5. On December 22<sup>nd</sup>, 2022 at 12:00 EDT, one draw will be held at the D-BOX office, using all entries collected from the Entry Form to select one random winner (“**Winner**”) from all Participants (“**Drawing Date**”).

### **PRIZE:**

6. One Winner will be drawn randomly as per the conditions of Section 5 and will be awarded with ONE (1) driving simulator consisting of: one Playseat Sensation Pro cockpit & seat, one Fanatec DD2 Wheelbase, one Fanatec Clubsport V2 Nascar Wheel for PC & Xbox, one Fanatec V3 Pedals and one D-BOX haptic system (G3 4250i 110volts or 230 volts) for the total value of \$ 14,055.00 USD (FOURTEEN THOUSAND AND FIFTY-FIVE US DOLLARS) (“**Prize**”).
7. The Prize is not transferable, assignable, or redeemable for cash. Any difference between advertised and actual values will not be awarded.
8. The Prize must be accepted as awarded and cannot be transferred, substituted with another prize or exchanged in whole or in part for money. D-BOX reserves the right, at its sole discretion, to replace the Prize with another of a comparable value if it is not possible to award it to the Winner as described in paragraph 6 above for any reason.

### **GENERAL TERMS AND CONDITIONS**

9. To be declared Winner, Participant whose Entry Form is randomly chosen for the Prize must respect the entry and eligibility conditions stipulated in this Sweepstake Rules including but not limited to Canadian Participants who need to have the Mathematical Question answered correctly. Failure to respect one or several of these conditions means the Winner will be disqualified and another random draw will be conducted to choose another Winner.
10. D-BOX will contact the Winner by e-mail. In the event that D-BOX is unable to reach the Winner of the draw for whatever reason within forty-eight (48) hours following the draw, D-BOX will conduct as many draws as necessary from the Entry Forms to find a Winner.
11. To claim the Prize, the Winner must fill in and sign a declaration of compliance and a full liability release (hereafter “**Compliance and Liability Form**”) that will be sent to such Winner by e-mail by D-BOX and return it by e-mail filled in and signed within fifteen (15) days of receiving it.
